

## Arizona Retail Florist Education Travel Grant Application Form

**Deadline: October 1 each year** 

The Arizona Retail Florist Education Travel Grant was established to serve traditional retail florists located in the state of Arizona. The fund initially was created through the efforts of Ken Young AAF while a member of the AFE Board of Trustees. Initial funds to establish the Grant originated from the defunct FTD District 8K with additional initial funding requirements coming from an Arizona floral industry member. The value of the fund has the ability to continue to increase with contributions from industry members made to AFE that are designated for the fund.

### **PURPOSE:**

Provide financial assistance for traditional retail florists in Arizona to pursue design and industry-related business educational experiences that allow exposure to fellow retail florists and floral industry members from outside of the state of Arizona, while providing opportunities for floral industry networking on a national level.

Each year, one recipient will be selected to receive an educational travel grant of up to \$1,000 to help cover the cost of attending an out-of-state industry educational event. The grant will be made as a reimbursement after the event is attended. The recipient can receive the grant once every five years.

#### **APPLICATION CRITERIA**

- Applicants must be owners, managers or employees of traditional retail florist shops with a brick and mortar storefront in the state of Arizona.
- Applications for this travel grant must be for an industry event in the coming year. For example, apply in 2017 for travel in 2018.
- Applicants must be requesting this grant for travel for floral design or industry-related business educational opportunities that take place outside of the state of Arizona.

Examples of eligible opportunities include floral design schools, FTD Boot Camp, Floriology Institute, Teleflora Academy Events, SAF Profit Blasts or Convention, State or Regional Floral Conventions, Cultivate, AIFD Symposiums, and others. The exception to the "out-of-state" travel requirement would be if a national program (like SAF Convention or AIFD Symposium) were held within Arizona, which would still allow for exposure to fellow out-of-state retail florists and floral industry members.
